SUBJECT: DISCUSSION/ACTION: IMPERIAL IRRIGATION DISTRICT REDISTRICTING DRAFTS 1. Review IID redistricting drafts and consider one of three potential actions: support one of the three drafts, propose a different plan or take no action.	
DEPARTMENT INVOLVED: Mayor call of special meeting	
BACKGROUND/SUMMARY: Imperial Irrigation District is conducting proceedings mandated by the California Elections Code which calls for redistricting to reflect results of the most recent census. IID has scheduled a public hearing for November 16, 2021, at 4:00 p.m. to receive public input on three draft plans. The law requires final action by December 9, 2021, so it is anticipated a second public hearing will be held and action taken prior to that date in order to meet the statutory deadline. The City of Imperial and unincorporated area within its sphere of influence are mostly contained in IID District 5. IID Redistricting Draft Map A removes land from the current boundaries of District 5 and adds that land to District 1. Those areas are roughly comprised of land known as Ironwood Acre Estates (unincorporated area) and Wildflower. The Wildflower area proposed to be removed under this draft includes La Brucherie to Austin south of Aten. Draft Map B leaves Ironwood, but removes Wildflower. Draft Map C does not remove Ironwood or Wildflower and achieves the population parity requirements by moving land from Holtville and Calxico.

The Imperial Irrigation District Board of Directors will hold a public hearing at 4 p.m., Tuesday, Nov. 16, 2021 in the Condit Auditorium, 1285 Broadway, El Centro, to discuss redrawing the boundaries for the five IID director divisions.

The purpose of the hearing is to engage the public in the redistricting process as the board will consider redrawing the IID division boundaries to be reflective of the population changes based on the 2020 U.S. Census.

Redistricting is important to ensure each director serves a balanced number of constituents. Final approval is due by Dec. 9, 2021.

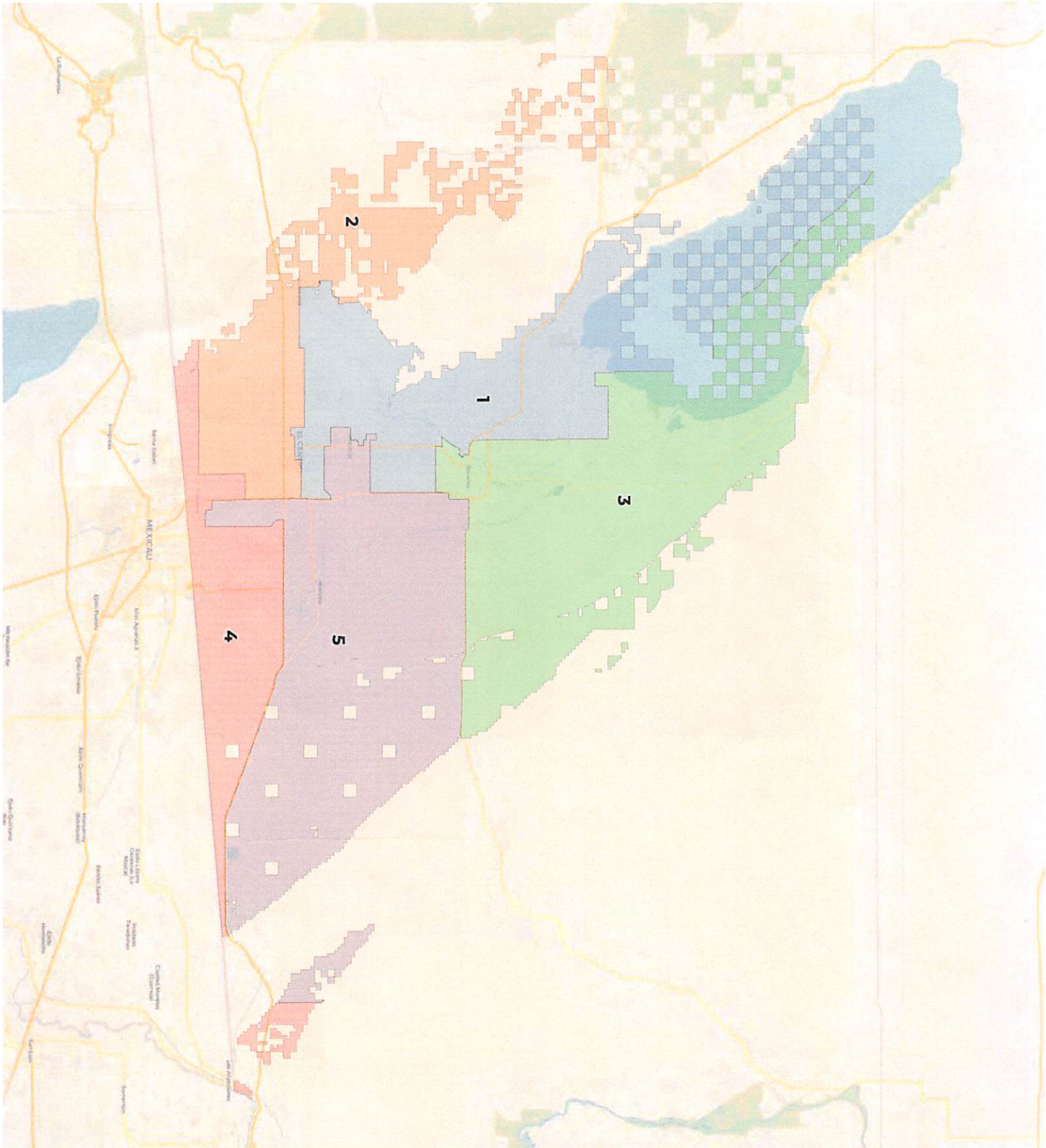

Draft Plan A

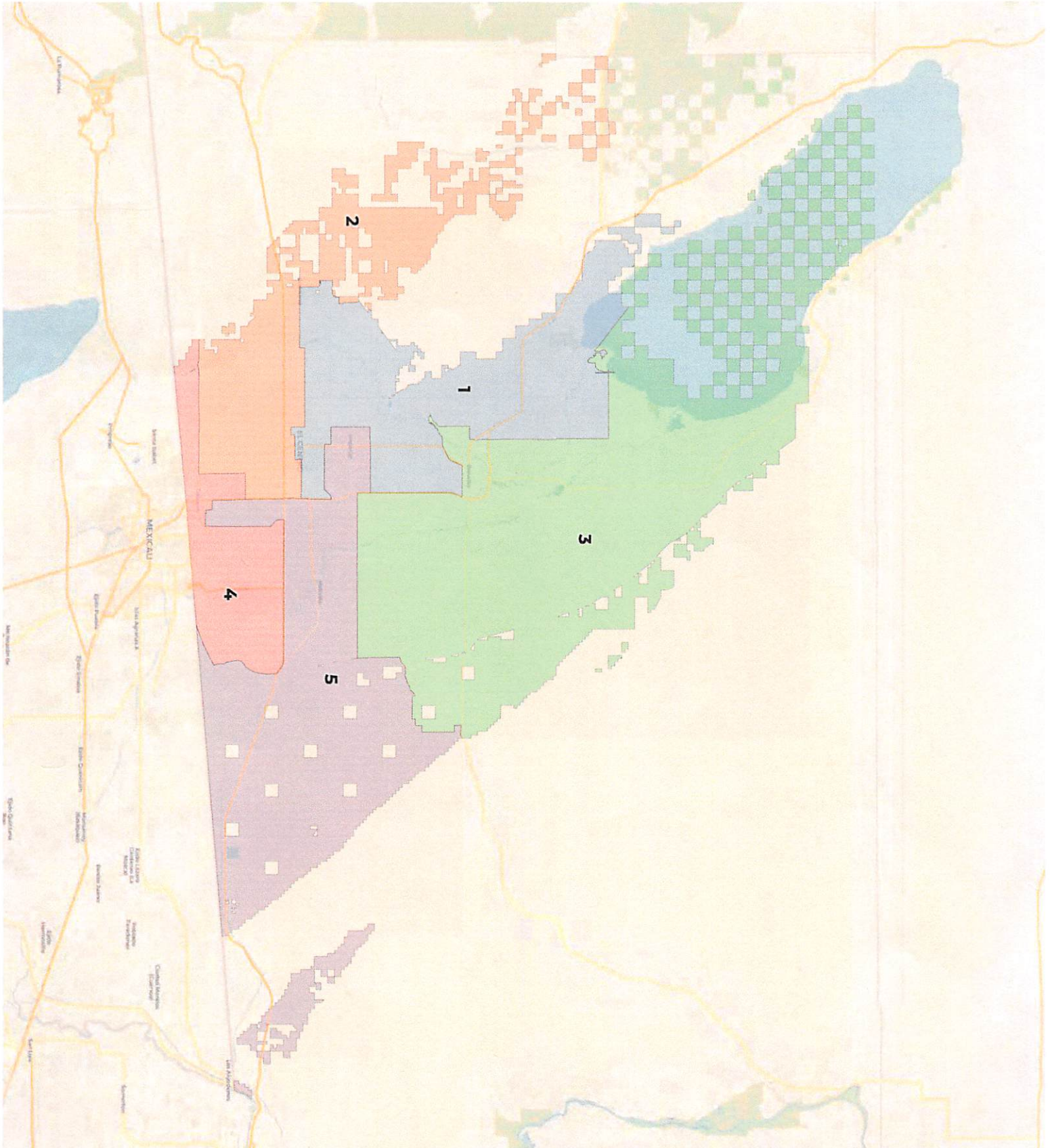
